## **BYLAW NO. 2168**

A Bylaw to Close and Remove the Dedication as Highway of a Portion of Nimmo Road

WHEREAS pursuant to Section 40 of the *Community Charter*, a Council may, by bylaw, close all of a highway to traffic and remove the dedication of the highway if, prior to adopting the bylaw, Council publishes notice of its intention in a newspaper and provides an opportunity for persons who consider they are affected by the bylaw to make representations to Council;

AND WHEREAS the Council deems it expedient to close to traffic and remove the dedication of highway from that portion of Nimmo Road comprising approximately 0.180 hectares created by the deposit of Plan VIP2100, which area is shown outlined in bold black on the Road Closure Plan;

AND WHEREAS notices of Council's intention to close that portion of highway to traffic and to remove its dedication as highway were published in the newspaper and posted in the public notice posting place, and Council has provided an opportunity for persons who consider they are affected by the closure and disposition to make representations to Council;

**AND WHEREAS** Council does not consider that the closure of the Closed Road will affect the transmission or distribution facilities or works of utility operators;

**NOW THEREFORE** the Council of the Corporation of the District of Central Saanich, in open meeting assembled, enacts as follows:

- 1. Attached to this Bylaw as Schedule "A" and forming part of this Bylaw is a copy of reference plan of highway closure EPP132484 prepared by Lloyd R. P. Eakins, BCLS (the "Road Closure Plan").
- 2. The District hereby authorizes the closure to traffic and removal of highway dedication of that approximately 0.180 hectare portion of the highway created by the deposit of Plan VIP2100 labelled "Closed Road" on the Road Closure Plan (the "Closed Road").
- 3. On deposit of the Road Closure Plan and all other documentation for the closure of the Closed Road in the Victoria Land Title Office, the Closed Road is closed to public traffic, it shall cease to be public highway, and its dedication as a highway is cancelled.
- 4. The Mayor and Corporate Officer are authorized to execute all land title instruments, plans, and other documentation necessary to effect this road closure.
