Established in 1966 under the BC Provincial Court Act, expanded under the Federal Youth Criminal Justice Act and now a delegated CRD commission, the VFCYJC is uniquely positioned to connect regional and municipal decision-makers with frontline service providers. Our voting members are elected representatives from the CRD's 13 municipalities and three school districts as well as CRD citizen appointees.

Highlights from the report:

- * Eight regular VFCYJC meetings and eight steering committee meetings
- * Approval of the 2023-2026 Strategic Plan
- * First annual Open House allowing members to meet with service providers
- * Grants awarded to the Victoria Youth Empowerment Society and Cornerstone Youth Society
- * Advocacy in support of the Pacific Centre Family Services Association's Crime Reduction & Exploitation Diversion (CRED) program in association with the Mobile Youth Services Team (MYST)
- * Presentations by the Hon. Mitzi Dean, SD #61 Chair Nicole Duncan, the Village Initiative's Cindy Andrew and University of British Columbia researcher Bill Warburton.

As I trust the report demonstrates, the VFCYJC remains a relevant, meaningful body dedicated to educating and advocating in support of the region's most vulnerable young people. Please visit our website to learn more.

THREE-YEAR STRATEGIC PLAN 2023-2026

The VFCYJC reviewed the Strategic Plan in 2023 and has adopted the following Plan for 2023-2026.

Mission:

To facilitate connections between municipal and First Nations governments, school districts, service providers, and the broader community in order to educate and advocate on the challenges and shortfalls facing youth and families who may come into contact with the justice system.

Vision:

Families and youth have access to timely and appropriate supports within their communities so that they may achieve their full potential.

Goals:

- 1. Increase awareness of the issues facing families and youth involved with the justice system, and raise the profile of the Victoria Family Court and Youth Justice Committee.
 - a. Identify gaps in services.
 - b. Support youth initiatives.
- 2. Pursue and promote meaningful reconciliation with the Indigenous community.
 - a. Committee members participate in Cultural Competency Training
 - b. Acknowledge and reduce the over-representation of Indigenous people in the justice system.
- 3. Advocate for policies and initiatives that improve outcomes for families and youth who may come in contact with the justice system.
 - a. Give a platform to youth/ amplify youth voices.
- 4. Support equity of access to resources across the region.
 - a. Help other organizations leverage their resources in support of families and youth.
- 5. Facilitate collaboration between community service providers and governance bodies in the interest of better supporting youth and families.

As Chair of the Victoria Family Court and Youth Justice Committee (VFCYJ), it is my honour to present the annual report for 2023.

As a delegated commission of the Capital Regional District (CRD) we continue to work towards our mission to facilitate connections between municipal and First Nations

To advocate for service agencies as they work on behalf of families and children throughout the CRD.



2023 YEAR-IN-REVIEW

January

New and returning members were welcomed to the Annual General Meeting by Chair Marie-Terese Little and Vice-Chair Adam Flint; both were returned to these positions for 2023 during the AGM election. Revised versions of the VFCYJC Terms of Reference and Constitution were adopted, the annual budget was approved and the 2022 Annual Report received. The Capital Regional District's Steve Carey shared a power point on the background of the VFCYJC and its new status as a designated CRD commission.

February

Chair Little presented an orientation for new and returning VFCYJC appointees. A reminder was shared that trainings offered by Victoria's Indigenous Perspectives Society are available at no charge to committee members. The Committee extended its appreciation for Bill McElroy's long-term role as treasurer and welcomed Esther Paterson to the role effective in June.

April

A new three-year Strategic Plan (2023-2026) that strongly reaffirmed the previous plan was approved by the Committee. Restorative Justice Victoria's Gillian Lindquist and the Mobile Youth Service Team's Mia Golden and Gord Magee provided updates on their respective organizations; each noted a marked increase in sexualized violence and gang activity in Greater Victoria.

May

The VFCYJC data base of Greater Victoria service providers and resource agencies was fully updated. A \$5.3k grant was awarded to the Victoria Youth Empowerment Society for its 2023 Summer Opportunities program.

June

A \$3k grant was approved for the 2023 Wellness Wednesday program run by the Cornerstone Youth Society (aka Sanctuary Youth Centre). Representatives from 13 resource organizations and three law-enforcement agencies attended the VFCYJC Open House, held June 13 at Victoria City Hall. This enjoyable meet-and-greet introduced VFCYJC members to a wide range of local heroes delivering essential services to young people and their families in Greater Victoria.

September

The Committee welcomed new appointees Karin Kwan (Vice-Chair, SD #61) and Corey Wood (District of Central Saanich Police Board). MYST's Mia Golden and Gord Magee spoke about the daunting new South Island challenge posed by gang recruiters from the Lower Mainland. SD #61 Chair Nicole Duncan addressed the school board's decision regarding the School Police Liaison Officer Program (see VFCYJC backgrounder). Members were reintroduced to the Qualification Matrix (Fillable), which identifies the skill sets and interests ideal for committee members and their alternates.



October

The Hon. Mitzi Dean, Minister of Children and Family Development, former Executive Director of the Pacific Centre Family Services Association and a VFCYJC member herself (2008-17), highlighted our multi-jurisdictional role in supporting service providers and the region's most vulnerable young people. "Your work is needed, recognized and appreciated." she said. UBC-affiliated researcher/economist Bill Warburton, another VFCYJC alumnus, shared a powerpoint presentation on his recent coauthored study identifying high-school graduation as a critical factor in healthy, happy adult lives. The data clearly shows that investment in strategic upstream invention for young people falling behind can have dramatic implications for BC's social, health and youth justice systems. Capital Region Action Team's long-time lead Bill McElroy delivered a 25th anniversary organizational update that included news of a refreshed website and an ongoing commitment to raising awareness about child and youth sexual exploitation in Greater Victoria.

November

Julie-Anne Hunter, ED of the Victoria Youth Empowerment Society, reported out on the impacts of this year's VFCYJC grant in support of the Summer Opportunities Program; 143 young people were welcomed off the street for counselling, group activities, life-skills training and healthy lunches and snacks. The Village Initiative's Cindy Andrew provided a powerpoint overview of this growing inter-disciplinary network of 40 organizations, each of which recognize that children, youth and families in the Sooke/ West Shore region are best served through "an all-hands-on-deck approach – a Village." She discussed TVI's new Trent's Trajectory infographic charting the ROI on upstream intervention; the campaign to bring a Foundry BC youth counselling centre to Langford (with affiliated outreach to Sooke and Port Renfrew); and other TVI priorities. A renewed MYST advocacy letter calling for steady, long-term funding and additional councillor/officer teams has been sent to Solicitor General Mike Farnworth: and the committee's X feed is operational again after technical difficulties, with posts again keeping pace with those on Facebook.

SUB-COMMITTEES

We ask that members join one of the sub-committees to assist in developing materials to bring forward to the main committee. Meetings may be held via email, at any appropriate venue, and chairs may incur expenses up to \$200 to facilitate meetings without advance approval. Chairs are encouraged to present a motion to the main committee for extraordinary expenses. Our goal is to make it easier for volunteers to meet while still maintaining fiscal accountability. The practice has been to try to reserve funding for work that supports youth and families while also supporting those who give freely of their time and expertise.

Priorities reviews completed applications in conjunction with existing VFCYJC policies and makes a recommendation in the form of a proposed motion together with their rationale to the main committee for their consideration at a regular meeting.

Communications supports outgoing communications, website content, advocacy efforts, agenda creation, and maintenance of the Facebook and Twitter accounts.

Youth & Family Matters brings information to the main committee on Family Matters, Youth Matters and monitors the circumstances that youth and families encounter during separation, divorce, and custody arrangements as well as documenting hot button issues for youth and encourages youth involvement.

Court Watch coordinates Indigenous and regular Court House visits to observe and report on the circumstances for youth and families.

CRAT stands for Capital Region Action Team for Sexually Exploited Youth. It advocates with expertise to address issues related to sexual exploitation, grooming, pimping, coercion, youth sex work and pornography.



PRIORITIES SUB-COMMITTEE (GRANTS) REPORT

All fully completed Applications will be reviewed by the Priorities Sub-Committee. The Chair will be responsible for inquiries and clarifications, and will circulate relevant information back to sub-committee members electronically. Through their considerations the sub-committee will provide their recommendation for each application as well as, their rationale for each qualifying application to the sub-committee Chair who will prepare a proposed resolution with a brief written report to the main Victoria Family Court and Youth Justice Committee (VFCYJC) for their considerations and their vote at a regular scheduled meeting.

The following are some of the current objectives' information to be provided within the Priorities (Grant) Application

1. Objectives

- **1.1.** The statement of intended outcomes within the application will be used to assess success of the project to accomplish goals.
- **1.2.** Applicant's statement must demonstrate in some detail the service(s) that your proposal would provide for youth and families of the CRD that ties in with the mandate for VFCYJC.
- **1.3**. Applicant's statement must indicate how your proposal will help educate and bring awareness to youth and families living within the CRD about reducing risks and reducing potential involvement with the judicial court systems.

The Priorities Sub-Committee for 2023 was composed of (VFCYJC) Chair: Marie-Terese Little, Treasurer: Esther Paterson, sub-committee Chair: Marcie McLean, and members Rose Stanton, and Sara Duncan. Current policy is that there should be 5 sub-committee members including the Chair of VFCYJC and its Treasurer.

In 2023 the sub-committee reviewed 3 applications, one of which was not supported for a grant.

The first application approved was from the Victoria Youth Empowerment Society (YES) in the amount of \$5,300.00 (their full request) towards their Summer Opportunities Program (SOP) which provided funds for a youth program (ages 13-18 from within the Capital Regional District) for the months of June, July and August, weekdays for 4 hours a day providing opportunities with trained, experienced staff to engage in recreational activities/outings and education in a number of areas relevant to life skills with marginalized youth that enhance a youth's future likelihood of making better choices in life, held within a safe supervised location in downtown Victoria where YES also can provide wrap-around services.

The SOP grant funding would also:

- Facilitate connections between service providers and the broader community for youth and families in the Capital Regional District,
- Help the Society leverage their resources in positive support of families and youth,
- Continue to be a cost efficient program if the Summer Opportunities Program has the past numbers of 120-200 youth participate,
- The Society's identified goals and objectives appeared to be relevant to the VFCYJC mandate as they
 focus on prevention and diversion during the summer months in order to reduce youths' overall risks,
 thereby also reducing the risks of youth possibly becoming involved with the judicial court system.

The second application approved was from Cornerstone Youth Society also known as Sanctuary Youth

Centre (SYC) for their proposed Wellness Wednesday Program (WWP) held on Wednesdays for 15 youth participants (ages 14-22 from within the Capital Regional District) in the amount of \$3,000.00 (which was not their full requested amount) towards mental health and skills training and curriculum materials.

Brief background from their application: Sanctuary Youth Centre (Sanctuary) serves youth aged 14-22 years who are actively seeking to exit hard drug usage and/or street life. Sanctuary has established a program called Wellness Wednesday Program (WWP), for 1 day a week on Wednesdays for up to 5 hours those days. To engage and mentor youth with outdoor recreational activities and education within a safe supportive supervised environment for street engaged youth providing opportunities for life skills and mental health and training skills curriculum, developing healthy relationships and lessening risky behavior and develop conflict resolution skills, potentially reducing involvement with the judicial court system, which appears to be relevant to the VFCYJC Mandate.

The Wellness Wednesday Program (WWP) also mentors, builds and reinforces protective factors against delinquency, lessening risky behavior and emphasizing skills for resiliency and coping, including conflict resolution skills. The WWP is intended to be a recurring program for the foreseeable future.

The sub-committee Chair sincerely acknowledges the time and efforts that the sub-committee members provided to the VFCYJC in reviewing grant application materials, their questions and thoughtful considerations in their recommendations with their rationales put forward to the main committee for their considerations and decisions through reports from the sub-committee Chair. Thank you!

The sub-committee chair also follows-up as needed in writing with applicants of approved applications if they have not complied with the Application's Terms and Conditions of Funding within the specified timeframe.

COMMUNICATIONS SUB-COMMITTEE REPORT

Communications is responsible for website maintenance and content creation, advocacy letter-writing, agenda creation and regular updates of the VFCYJC's Facebook and X accounts. In 2023, the subcommittee was comprised of myself, Darlene Rotchford, Adam Flint and Krista Loughton.

A prime focus was continuing advocacy on behalf of Greater Victoria's Mobile Youth Services Team (MYST). Following up last year's campaign that led to Minister Farnworth's announcement in the spring of one-year funding, the sub-committee sent additional letters of thanks for this action (May) along with a renewed request (November) for stable, long-term funding and additional councillor/police officer teams to intervene with a growing number of Greater Victoria youth in crisis. Advocacy also included in-person discussion by Chair Little and Councillors Loughton and Rotchford with Ministers Mitzi Dean and Grace Lore.

For the first time, the VFCYJC website is being routinely updated with fresh content arising from regular meetings. Grant opportunities are now highlighted prominently on the site's home page along with easy access to the application form. The Community Resources and Reports page has been extensively revised with additional organizational contact information and links to new reports. The website's Members Area is refreshed with agendas as they're released.

Social media posts continue on a semi-regular basis for a small audience of followers. Facebook posts have been consistent. CAPITAL REGION ACTION TEAM REPORT

2023 marks the 25th Anniversary of the Capital Region Action Team for Sexually Exploited Youth. It was formed as a result of the "Kiddie Stroll", where underaged youth were selling themselves quite openly and visibly on the streets in Victoria. This created demands that the City do something about the issue. We have come a long way, but unfortunately, the issue of the sexual exploitation of children and youth has not gone away. The big change in the past 25 years is that it has moved from the streets to the internet. There is also an increase in gang involvement in the exploitation of our community's youth.

There have been many challenges in 2023. Covid has meant a turnover of staff in many of the agencies that work with youth, and in many cases replacements have not been named. The Victoria Family Court and Youth Justice Committee was restructured and in the process, there was some confusion about where CRAT would fit into the new structure. All our meetings were conducted via Google Meet, and we only met 4 times during the year, down from our usual 5. In 2024, we expect to meet 4 times per year.

One other complicating factor this year has been our website. For some reason, we were not notified that our crat.ca website was up for renewal. We found out only when we were notified that someone else had secured the website, and was trying to sell it for \$5,000! We did not buy it, but instead worked with our computer developer to secure a new website, which is capitalregionactionteam.ca We have now transitioned all our material to the new website, and are just working on the details to keep it updated.



Over the summer, a team of 3 people met to update our purposes. At the end of this process, it was decided that our purpose would remain the same: raise awareness of the issue of the sexual exploitation of children and youth, educate youth about the issue and identify gaps in services for youth who have been or might become sexually exploited. We will monitor how we fit in with the new structure of the Victoria Family Court and Youth Justice Committee and review our structure toward the end of 2024.

CRAT is in a healthy financial position, with \$13,693 in its account. It should be noted that CRAT received a legacy in 2010 of \$12,000 in order to develop a graphic novel on the issue of the sexual exploitation of youth. We have been moving forward with this project and hope to have it completed by the fall of 2024.

In the past, we brought over Taking Care of Ourselves, Taking Care of Others (tco2) every year to put on interactive presentations to school children, mainly at middle schools. We have not done this for 3 years due to Covid and also because of some concerns about the quality of the presentations. This issue will be re-examined in 2024.

Dear Deputy Premier Farnworth,

On behalf of the Victoria Family Court and Youth Justice Committee, I would like to sincerely thank you and your staff for securing one-time funding last month to enable another year of essential work by the Pacific Centre Family Services Association's Crime Reduction & Exploitation Diversion (CRED) program in association with Greater Victoria's Mobile Youth Services Team (MYST).

CRED's Mia Golden and her MYST partner, Constable Gord Magee from the Victoria Police Department, have told the VFCYJC in recent months that the crisis continues to escalate alarmingly. As the only two-person CRED/MYST team in the region, the pair are currently working on 150+ active case files involving children and teenagers at severe risk of exploitation, homelessness, sexualized violence, drug addiction and gang recruitment.

Ms. Golden noted at our April 27 meeting that she's seen an influx of gang representatives from the lower mainland seeking new members in Greater Victoria. The tide of violence on our streets is rising and online exploitation is increasingly normalized, she said. Young victims are experiencing trauma, including suicidal ideation. Even more disturbingly, the perpetrators themselves are often very young themselves.

VFCYJC members, who include municipal councillors, school district trustees and Capital Regional District appointees, recognize the complexity of these issues and applaud the response by all orders of government, your Ministry and Greater Victoria Integrated Police Units very much included.

This said, we wish to echo our original advocacy letter of Oct. 7, 2022 (which was supported by the CRD Board of Directors and municipal councils in Metchosin, Colwood and Sooke) by re-stating the following:

- * the critical need for stable, long-term funding for CRED/MYST;

VFCYJC members, who include municipal councillors, school district trustees and Capital Regional District appointees, recognize the complexity of these issues and applaud the response by all orders of government, your Ministry and Greater Victoria Integrated Police Units very much included.

RESTORATIVE JUSTICE VICTORIA

While <u>Restorative Justice Victoria</u> is not a VFCYJC Sub-Committee, most restorative justice organizations in BC began with involvement of a Youth Justice Committee and we are particularly proud to support the one operating in the Greater Victoria region.

Each organization is unique in response to the needs identified in our communities. The VFCYJC was a contributor to RJV's evolution in Victoria – funding the production of video presentations, supporting youth-led initiatives, and facilitating volunteer education through the provision of resource materials.

Restorative Justice Victoria is very much a success story, overcoming the differences in the provision of police services to become an organization of accomplished, skilled volunteers who can be relied on to support better outcomes for all participants who access this 'accountable option' after a crime.

RJV's volunteers are asked to provide these better outcomes for increasingly complex cases throughout the CRD even while RJV funding remains critically insecure. No less than 15 resolutions about restorative justice were sent to the Union of British Columbia Municipalities between 1999 and 2018 calling on the provincial government to support restorative justice. While 11 of these resolutions were carried by the UBCM membership, substantial action is still required.
