RE: INVITATION TO PARTICIPATE: REGIONAL TRANSPORTATION GOVERNANCE WORKSHOP

Transportation is a 2023-2026 Capital Regional District (CRD) Board term priority. Following up on the summer and fall of 2023 engagement, the CRD is hosting a workshop for mayors, council members, First Nation Chiefs and councils, electoral area directors, and staff to discuss potential transportation service categories in detail. The CRD Board expects to consider a service establishment bylaw in fall 2024.

The full day workshop, scheduled for May 24, 2024, is the opportunity for input into the potential scope of a regional transportation service. Participants will be able to discuss proposed service categories with peers and transportation professionals and give the CRD feedback. Feedback from the workshop will be used to prepare a draft service establishment bylaw for the CRD Board's consideration.
