Thank you for writing in, unfortunately, I was unable to find your original correspondence from last year in my quick search but from your correspondence I think get the general idea.

Currently, the District does not have sidewalk/pathway construction for an east-west road planned within the next few years, but have Hagen in the queue based on feedback from our 2021 Active Transportation Plan public consultation. Our current Active Transportation Plan can be found on the District's website <a href="here">here</a>.

For my understanding, are you suggesting a referendum to borrow funds to carry out sidewalk construction? And are you suggesting that the questioned voters be the residents of the area? There may be issues with just a referendum for a specific group and area with funds coming from the whole municipality and something we need to look into. Additionally, referendums require a concrete question, like "are you in support of the municipality borrowing \$XXXXX to construct YYYY", with a full voting process and bureaucratic process with the Inspector of Municipalities, are you suggesting this or a fulsome public engagement process?
