

THE CORPORATION OF THE DISTRICT OF CENTRAL SAANICH

BYLAW NO. 2203

A Bylaw to Provide Tax Exemptions for the
WSÁNEĆ Lands Trust Society known as ʔIKEL lands (ten properties) for years 2025, 2026, 2027, 2028,
2029, 2030, 2031, 2032, 2033 and 2034

WHEREAS in accordance with Section 224 of the *Community Charter*, the Municipal Council may, by Bylaw on or before October 31 in any year, exempt lands or improvements from taxation under Section 197 of the *Community Charter*;

NOW THEREFORE, the Municipal Council of the Corporation of the District of Central Saanich, in open meeting assembled, enacts as follows:

1. The following described lands are exempt from taxation prescribed under Section 197 of the *Community Charter* for the calendar years 2025, 2026, 2027, 2028, 2029, 2030, 2031, 2032, 2033 and 2034:
