
REZONING APPLICATION – 6922 SAANICH CROSS RD

This is to notify you that Council will consider First Reading of a BYLAW to AMEND the current Residential Neighbourhood (RN) zoning to a site-specific Residential Neighbourhood zoning for a proposed 3 lot subdivision with secondary suites.

Under Provincial Bill 44, the District is prohibited from holding a public hearing on this matter.

A DEVELOPMENT PERMIT APPLICATION with VARIANCES has also been requested to include the following:

- Reduce the minimum lot frontage from 22.0m to 8.91m for proposed lot 1;
- ➤ Reduce the minimum lot frontage from 22.0m to 15.18m for proposed lot 2;
- ▶ Reduce the minimum lot frontage from 22.0m to 14.71m for proposed lot 3;
- ➤ Reduce the minimum rear setback from 7.0m to 6.4m for proposed lot 1;
- ➤ Reduce the minimum rear setback from 7.0m to 4.5m for proposed lot 2;
- ➤ Reduce the minimum rear setback from 7.0m to 4.66m for proposed lot 3;
- ➤ Reduce the minimum front setback from 6.0m to 5.91m for proposed lot 1;
- Reduce the minimum front setback from 6.0m to 4.78m for proposed lot 2; and
- ▶ Reduce the minimum parking requirement from 3 to 2 spaces for proposed lot 2.
