

The council appears to believe that they are not accountable to anyone and are forgetting that it is we, the citizens who are paying them to make decisions meant to be in OUR best interests and it is OUR money they are using, especially if they are to enter into legal proceedings over the compulsory purchase of the land at Hovey. Frankly, riding roughshod over the OCP and changing our environment without any consultation from us is appalling and unacceptable. I believe that I have read recently that the council has over-achieved already it's required quota of new dwellings for the area as set out by the BC Government. Multi unit properties are not the answer. They destroy neighbourly interaction and are ugly. Central Saanich is a rural/semi rural area and should remain so. In the future with climate change, we may need all the land we can get in order to produce food and we cannot use it if it's been concreted over.

Having previously had dealings for several years with the council and the CRD Parks Committee, as a member of the Committee of Friends of Island View Beach, my experience tells me that even though these bodies might have public meetings, they already have made up their minds about what they wish to do, and the meetings are simply for show to make it appear they are willing to listen. We know that, because the majority of the time, they go ahead with their plans anyway.




